PERSHING COUNTY ECONOMIC DEVELOPMENT STRATEGIC PLAN PRESENTATION:

Heidi Lusby-Angvick, Executive Director of the Pershing County Economic Development Authority (PCEDA), presented a Power Point presentation outlining the progress the PCEDA plan committee has made in establishing a Strategic Plan for the organization and asked for input from the City and County regarding the Plan.

Phase I of the project was community data collection and Phase II consisted of analyzing the data and developing draft Mission and Vision Statements. Both Phase I and Phase II are completed.

The draft Mission Statement is:

Pershing County Economic Development Authority is a public entity that through community collaborative efforts develops, retains, expands and attracts businesses that will strengthen and maintain the rural Nevada lifestyle.

The draft Vision Statement is:

Creating a vibrant and prosperous community where business and industry thrive.

The items on the SWOT (Strengths, Weakness, Opportunities, Threats) list were explained and discussed. The most important issues in the development of the Strategic Plan were presented as housing, workforce, marketing/promotion/branding, business recruitment, expansion and retention, and organizational capacity. The next step for the committee is to finalize the Mission and Vision Statements and develop strategic directions and goals. The information will be presented to the City Council and County Commission when it is completed.

Councilman Rowe moved that the City support the PCEDA Strategic Plan and the proposed Plan direction as presented.

Commissioner Rackley moved and Commissioner Shank seconded that the County support the PCEDA Strategic Plan and the proposed Plan direction as presented.

Motion passed unanimously.
