PUBLIC COMMENT-PERSONAL COMMUNICATION-CORRESPONDENCE:

There were no comments from the public. The City received a letter and pictures from Audrey Munk concerning the weeds, cars and general look of the town.

MINUTES REVIEW-APPROVAL:

Council member Rowe moved to approve the December 7, 2021 City Council regular meeting minutes as presented.

Motion carried unanimously.

BANK ACCOUNTS / MOVE FROM WELLS FARGO BANK TO NEVADA STATE BANK:

Mayor Giles explained there are two accounts with Wells Fargo Bank (WFB), a CD and cafeteria account. WFB advised the CD account must be moved. After working with WFB for the past six months, the account is still not moved. Giles suggested the accounts be moved from WFB to Nevada State Bank (NSB) because NSB has been easier to work with.

Council member Reynolds moved to authorize moving the City accounts at Wells Fargo Bank to Nevada State Bank as requested and to authorize the mayor to sign any required account documents on behalf of the City.

Motion carried unanimously.

AMERICAN RESCUE PLAN ACT (ARPA) FUNDS:

Spending the allocated funds on broadband services is an allowed use. The Council suggested that if the funds could be used for economic stimulus, they should be used to help revitalize the downtown area.
