PUBLIC COMMENT-PERSONAL COMMUNICATION-CORRESPONDENCE:

There was no public comment, personal communication or correspondence.

MINUTES REVIEW-APPROVAL:

Council member Rowe moved to approve the February 15, 2022 City Council-County Commission joint meeting minutes as presented.

Motion carried unanimously.

Council member Rowe moved to approve the February 15, 2022 City Council regular meeting minutes as presented.

Motion carried unanimously.

BUSINESS IMPACT DETERMINATION:

After review and consideration of the probable effect that each agenda item for this meeting could have on a "business" as defined by statute, Council member Gentry moved to make a finding that no item on this meeting agenda appears to impose a direct and significant economic burden on a business or directly restrict the formation, operation or expansion of a business.

Motion carried unanimously.

COUER ROCHESTER MINE EXPANSION PROJECT / COUER REPRESENTATIVES:

Chantae Lessard from Coeur Rochester mine reported on the ongoing activities and projects, provided a PowerPoint presentation and she and Frankie Graham answered questions.

No action was taken.

SEWER-DISPOSAL ACCOUNT DELINQUENCIES / ADJUSTMENTS / REFUNDS:

There were no reports.

No action was taken.

PUBLIC HEARING / NUISANCE DETERMINATION / 1155 CENTRAL AVENUE:

Photographs of the property taken earlier in the day showed that some cleanup had taken place, but there were still areas with accumulated debris which appear to be hazardous.

Council member Reynolds moved to extend the time to clean the property until March 15 at which time the status will be reconsidered.

REGIONAL PLANNING COMMISSION APPOINTMENTS / GALEN REESE - LOU LUSARDI:

PERSHING COUNTY CODE ENFORCEMENT OFFICER SERVICES:

Council member Reynolds questioned if it may be beneficial for the city to partner with the county to use the services of the county code enforcement officer to investigate and pursue possible nuisances in the city. City Clerk Wilcox said she believes it will be more beneficial to keep the services in-house. Wilcox suggested that the city ordinances need to be updated and implemented before pursuing code enforcer services. After discussion, the consensus was that the code enforcement proposal should be discussed and developed in a workshop session.

AMERICAN RESCUE PLAN ACT (ARPA) FUNDS:

City Clerk Wilcox distributed a list which summarized the various suggestions for utilizing the ARPA funds. After discussion, the consensus was that the proposals for using the ARPA funding should be discussed and prioritized in a workshop session.
