# CITY HALL OFFICE SPACE RENTAL AGREEMENT RENEWALS / LOVELOCK MEADOWS WATER DISTRICT AND PERSHING COUNTY ECONOMIC DEVELOPMENT AUTHORITY:

Mayor Giles suggested leaving the rental rates and terms of the rentals as they were under the prior rental agreements.

Council member Rowe moved to approve renewing the rental agreements with the Water District and Economic Development Authority on the terms as proposed.

Mayor Giles briefly explained the plan and proposed the prior fiscal year capital improvement plan be adopted as the current fiscal year plan, which only requires a change of the dates on the (prior) plan before submission to the state.

Council member Gentry move to approve the five-year capital improvement plan priorities as explained and proposed.

Motion carried unanimously.

## **SURPLUS EQUIPMENT PURCHASE:**

Mayor Giles opened and read aloud the sealed bids for the declared surplus equipment, as follows: Laura Iniguez (the only bidder) bid \$650 for the 2001 GMC pick-up; and, Darrell Mancebo (the only bidder) bid \$550 each for the 2004 Ford Crown Victoria and the 2009 Ford Crown Victoria, for a total of \$1,100. There were no other bids.

Council member Gentry moved to accept the bid of \$650 for the 2001 GMC truck from Laura Iniguez.

Motion carried unanimously.

Council member Rowe move to accept the bids of \$550 each for the 2004 Ford Crown Victoria and the 2009 Ford Crown Victoria, for a total of \$1,100, from Darrell Mancebo.

Motion carried unanimously.

#### STAFF-COUNCIL REPORTS-PROPOSALS:

Legal Counsel Maher reported that some local governments are concerned the America Rescue Plan Act money delivered to the state is not being distributed to the local governments as initially promised and are calling for an investigation.

Mayor Giles reported: (i) the police officer candidate who has been unsuccessful in satisfactorily completing the Nevada POST course has been accepted in a 22-week out of state program; (ii) a letter was received from the Department of Taxation indicating the final city budget is compliant with law and regulation; (iii) Shaw Engineering issued an invite to a BBQ to celebrate 40 years in business; (iv) the bishop from the Episcopal church is still interested in selling the local church property and NRHA is interested in purchasing the property with ARPA funds; (v) the parking code, unregistered vehicles, building permits, building codes and business licenses need to be on the agenda to discuss; and, (vi) the bathrooms at the strip park were vandalized again and the graffiti was covered with black paint.
